Hometown Heroes - Building Out Future. When your hometown needs help, it's time for everyone to step up and become a Hometown Hero.

The Heroes' Backstory

For the 15th consecutive year, the Nebraska Investment Finance Authority (NIFA) hosted its Housing Innovation Marketplace, an annual conference that brings together lenders, developers, real estate professionals, non-profit organizations, and city/community leaders for educational sessions and networking opportunities.

The 2017 conference theme, "Hometown Heroes: Building Our Future," built upon the successful social media marketing campaign deployed for the 2016 conference, further highlighting the views and experiences of conference attendees by participation through various social media sources. NIFA's strategic objective was to involve conference attendees before, during and after the 2017 conference. The Hometown Heroes media campaign achieved that objective and more. Using social media as a tool, NIFA was able to target our communications to particular groups of potential attendees resulting in a fun and interactive way to promote the 2017 conference, its theme, and shine a light on stories about community heroes across the state. This was all done at minimal cost to NIFA.

To engage attendees around the conference theme, we encouraged them to recognize a **Hometown Hero** that had made a difference in providing or promoting the development of affordable housing in their respective community. Upon registration, attendees were asked to submit stories and photos about a "**hometown hero**" through social media using the tag **#NEHometownHero**. These stories and photos were released through our Facebook (**NIFAHousing**) and Twitter (**@NIFAHousing**) pages to create excitement about the upcoming conference, encourage attendance and provide a preview of the type of affordable housing discussions that might occur at the conference. Attendees who submitted **Hometown Hero** entries prior to the commencement of the conference were provided with a \$25 discount on their registration fee. A slideshow that included a compilation of the stories and photos submitted was shown at the conference during all general sessions and in materials featuring the Heroes which were included as a part of the information provided at the registration table.

The Hometown Heroes Materials and Promotion

NIFA used various materials and mediums in the marketing strategy and promotional efforts for **Hometown Heroes**. Promotion of the conference was entirely paperless through email postcards and social media, enabling NIFA to reach a large and targeted the audience at a fraction of the cost of printed mailings. Themed postcards and flyers were distributed via email and posted on NIFA's website, Facebook, and Twitter.

To add a bit of fun during the conference, NIFA strategically placed a photo booth in the Exhibitors' area of the conference hall. Conference attendees could visit the photo booth and dress up as super-heroes to take super-hero themed photos together. These photos were shared online after the conference for everyone to enjoy.

Exhibitors in the conference hall were able to easily engage and interact with attendees as a result of the close proximity to the photo booth. Additionally, conference attendees were encouraged to visit each exhibitor and collect stamps on their "bingo" card. Those collecting stamps from all of the exhibitors were eligible to participate in a drawing for a number of prizes, including two free registrations and hotel stay for NIFA's 2018 conference.

The submission of **Hometown Hero** stories prior to the conference provided a platform for conference attendees to further share the successes, opportunities and projects in their respective home towns. The **#NEHometownHero** submissions were displayed in a continuous loop slideshow throughout the conference, including during general sessions and all meals, giving conference attendees the opportunity to learn more about the strategies and types of activities taking place to provide affordable housing in our Nebraska communities.

The **Hometown Hero** "mascot" appeared in attendee conference bags in the form of a character "stress doll" to provide a further reminder of the conference theme. In addition to their stress doll, attendees received a flash drive containing the 2017 Nebraska Profile, an annual report commissioned by NIFA that includes demographic, economic, and housing information for the state. Samples of those materials can be found in the attached exhibits.

NIFA staff, adorned in special **Hometown Hero** conference t-shirts, were easily identifiable to conference attendees and provided information and guidance throughout the conference.

The Hometown Heroes Conference

Hometown Heroes was held on March 21-22, 2017 at the La Vista – Omaha Conference Center. The conference kicked off with the "Get to Know Your Exhibitors" breakfast where attendees had the chance to visit with exhibitors in our dedicated "Innovator's Hall." Courtney Dentlinger, Director of the Nebraska Department of Economic Development, welcomed attendees in the general session breakfast. For the remainder of the morning, attendees could choose from five tracks of break-out sessions: Single Family, Multi-family, Technical Topics, Housing and Homelessness and new this year-Workforce Housing.

In setting the agenda for the 2017 conference, NIFA not only built upon the feedback received in connection with prior NIFA conferences, but also considered how to best provide additional value to attendees by incorporating new and timely topics. The provision of "workforce housing," particularly in the non-metropolitan areas of Nebraska, has become a topic of intense discussion. For many conference attendees, the workforce housing track provided a unique opportunity to learn more about the issue and network with others facing the same or similar housing challenges. Additionally, for the third straight year, NIFA featured several sessions focused on topics particularly relevant to the development of housing to better serve the Nebraska's Native American population.

Hometown Heroes were recognized during the conference luncheon with the presentation of NIFA's Housing Champion Award, Lifetime Achievement Award, and Rural and Urban Realtor Awards. Attendees were then treated to an inspirational speech from documentary filmmaker Brett Culp. Brett showed a short clip from his super-hero themed documentary "Legends of the Knight" and then encouraged attendees to step up and become **Hometown Heroes** in their own communities. The afternoon continued with break-out sessions and wrapped up with a Networking Reception, complete with live, local Nebraska entertainment from blues singer, John "Honeyboy" Turner.

Day two of the conference began with the "Sponsor Recognition Breakfast." The morning continued with break-out sessions. The conference wrapped up with an awards luncheon where two **Hometown Hero**-worthy individuals were inducted into NIFA's Housing Hall of Fame. Awards were also presented for "Property Manager of the Year," the "Innovative Project of the Year," and for the "Making a Difference" partner collaboration award.

The Big Results


The **Hometown Heroes** social media campaign reached across county and state lines resulting in 419 registered attendees from 38 Nebraska communities and 15 other states. A record 34 exhibitors were on hand and a total of 16 sponsorships were obtained, contributing a total of \$37,500. Continuing Education credits were provided to real estate professionals, attorneys, accountants and mental health professionals.

Based on the results of an online evaluation survey completed by 79 attendees following the conference, **Hometown Heroes** had an overall average rating of 4.5, with 5 being the highest rating. The success of the 2017 conference has set the bar even higher for 2018. NIFA intends to continue to follow the template that has been so successful for its conferences, incorporating innovative, fun, meaningful and interactive themes that encourage attendees' participation and draw attention to our annual conference that is focused on the housing needs of Nebraska.

The strategies used by NIFA in connection with its **Hometown Heroes** conference can easily be replicated by other Housing Finance Agencies. The overall theme and encouragement to share **Hometown Hero** stories and events stimulated an energetic, interactive environment that created a vibrant conference. We hope others are inspired to think about their **Hometown Heroes**!

Brett Culp is an acclaimed filmmaker whose work has inspired audiences around the world. He is the personal cinematographer for Hollywood stars, music icons, beloved authors, hall of fame athletes, and royal families. His films have been featured on Netflix, iTunes, Hulu and other top digital platforms.

With his uplifting documentary film Legends of the Knight, Brett pioneered a ground-breaking approach to community building and relationship-driven engagement. Rather than launching this feature film through normal distribution channels, he offered anyone in the world the opportunity to screen it in their local movie theater with proceeds benefiting the charity of their choice. This unique plan gave individuals the freedom to use the movie as an open-source tool for bringing people together to make a positive impact.

Without a single dollar spent on marketing or advertising and no paid staff, the feature film successfully screened in theaters in over 100 cities across the globe raising nearly \$100,000 for charity. Each showing was hosted by local volunteers who took the initiative to organize and promote the event. Brett inspired thousands of people, many of whom had never planned a community event, to become leaders engaged in a passionate mission.

Brett's work as a filmmaker has built MORE than a fan base of followers. He empowers people to find their own path to leadership. He has been featured in USA Today, Entertainment Tonight, WIRED, The LA Times, The Hollywood Reporter, Lifetime, WEtv, and many more. He is co-founder of The Rising Heroes Project, a 501(c)(3) that supports charitable organizations and empowers community leaders.







Jim Hawks, North Platte City Administrator, has consistently supported the work of Lincoln County Community Development Corp (LCCDC) in developing and rehabilitating affordable housing in the community. We consider him a HERO for housing in many ways.

Jim has provided for a portion of operating funds to the LCCDC from the City budget annually since at least the year 2000. The City has also partnered in demolition/new construction projects by providing funds for demolition of condemned structures. This allows the LCCDC or other nonprofit to then buy the property and build affordable new homes to fill those empty lots. Most recently, in 2016, the City of North Platte applied for CDBG funds to support owner-occupied rehabilitation projects. Under Jim's administration, the City staff is willing to provide assistance whenever appropriate...this includes planning and zoning, building inspections and code enforcement.

In addition to the help he has provided to LCCDC, Jim has worked to improve infrastructure in the community to allow for growth. He has also worked tirelessly to revise flood zones in order to facilitate construction and reduce costs to homeowners for flood insurance. Ty Lucas



Ty Lucas has been a champion of community development since returning to his hometown of North Platte and joining NebraskaLand National Bank in 2002. In 2015 Ty became a HERO for housing when as Board Chair of the North Platte Chamber & Development Corporation he took on the issue of affordable and desirable housing in the community. Ty recognized that there were good jobs available in North Platte, but that the community lacked the necessary housing inventory to meet the needs of these individuals and families.

Ty worked with the Chamber & Development Corp to develop strategies to

address the issue. The first was to launch a program called a "Shot in the Arm for Housing". This investment was made to increase housing inventory and jump-start local housing construction. The program was a unique partnership that combined Chamber & Development incentive funds with the City of North Platte's LB840-Quality Growth Fund to form a \$344,000 "Incentive Pool". Builders who qualify for the program receive \$8,000 for each dwelling after interior drywall is installed.

Currently there are 48 homes that have either been built or are under construction as a result of this program. This includes two single family homes and two duplexes being built by Lincoln County Community Development Corporation. Over \$7.5 million is projected in new construction, along with \$100,000 generated in city sales taxes and \$250,000 in new real estate taxes.

Ty also serves on the Nebraska Bankers Association Workforce Housing Task Force to develop statewide initiatives addressing affordability and availability of housing in rural Nebraska. Submitted by: Carol Nelson Bodeen

Sandra Roemer



The Monument View Villa complex was a 1.7 million dollar deal involving NIFA tax credits, MHEG as Syndicator, NDED HOME funds and AHP / FHLB of Topeka, Kansas.

Rev Harry Waller

I would like to nominate Rev. Harry H. Wallar for the "Home Town Hero" Rev. Wallar is disabled veteran that dedicated his life to serving the homeless and near homeless of our community by founding New Visions Homeless Services. Pastor Wallar was born and raised in Omaha, NE. Under Pastor Wallar's direction and love for serving the less fortunate, New Visions Homeless Services built two campuses in the Omaha Metro Area. One is located in Council Bluffs Iowa serving the homeless and near homeless of our community and our other is in Omaha, Ne that offers 40 apartment to homeless veterans at no cost to the veteran.

In August of 1993 Rev. Harry and Ginny Wallar started a church in the community out of a old catering hall. Soon after, Pastor Wallar began to feed hungry people out of a little white van. The church parishioners would make sack lunches consisting of 2 peanut butter and jelly sandwiches, a bag of potato chips, a piece of fruit, and a juice box. He and several committed parishioners would take the van under the viaduct, into tree lines, and on the interstate looking for the hungry and the homeless. They would simply walk up to them and hand them a lunch and walk away.

Approximately six months later during a Sunday afternoon message Pastor Wallar stopped in the middle of his sermon and stated "I am going to buy a bus and we will build a mobile kitchen and feed the homeless and the hungry" and continued his message. Just like he had spoken the next Sunday morning a big yellow school bus was sitting in front of the Church. After several months of hard work the "Mobile Kitchen" was born. The Church began to provide meals to the homeless every night from 5:00 p.m. until 6:30 p.m. the bus would pull under the viaduct in Council Bluffs, lowa and feed the homeless and the hungry. For two years the bus would be in the same spot every night, seven days a week.

The need was so great that Pastor Wallar soon realized that they needed a building to continue their feeding program. He spotted an old hardware store just a block away from where the bus parked and struck a deal with the owner. Seven months later "MOHM's Place" (Messengers of Hope Ministry) was in operation feeding the hungry men, women, and children, that would come every night to eat. Pastor Wallar began to rally organizations that provided services to this population and soon there were 13 different agencies providing 69 different services all aimed at assisting the homeless and near-homeless of our community. Sensing the need for expanded services Pastor Wallar began to pursue a vision God had given him to build a complex for the homeless in our city. It has been estimated that they served over one million meals in that building.

In September 2008 Pastor Wallar's vision came to pass, with the help of Central States Development Company, New Visions Homeless Services moved into the "New Visions Complex." They literally made history in building the first 62 bed men's shelter, 26 transitional living unit for single men and single women, a meal site that would seat 250, and an administration building for the homeless and near-homeless of Council Bluffs. This complex t is the first of its kind in all of Southwest Iowa. It is nearly 26,000 sq. ft. under roof and it is built with excellence. Currently we are sleeping approximately 100 men per night in our shelter, our transitional living unit is full with a waiting list of about 20, and we feed approximately 6,000 meals monthly in our meal site.

New Visions Omaha was built in 2012. This is a complex with 26 Transitional living units for honorably discharged veteran's and 14 permanent supportive housing units for veterans who are homeless. This campus is unique to our community as it provides the veterans their own apartment at no cost to them all while providing life saving wrap around services.

Pastor and Ginny Wallar also operate "MOHM's Place Thrift Warehouse" and a lawn service to supplement the operational funding streams. All of the profits are returned to the ministry to help us feed the homeless and hungry of our community.

The target population for New Visions Homeless Services are those who are homeless or near homeless in

Southwest Iowa and in Sarpy and Douglas Counties in Nebraska. Our programs are individually designed to meet the unique needs of this overall population by serving different groups of homeless or near homeless.

MOHM's Place Meal Site: Open to the community, serving breakfast, lunch, and dinner to those needing food security. Through this program, along with meals, New Visions offers food pantries, personal care items, access to health screenings through AllCare Community Health Center, and links to community support services such as mainstream benefits, case management, housing programs, and addiction treatment. This is often the entry level of our other program participants, as we work to connect with individuals coming to the meal site for food and offer outreach services. Submitted by: Brandy Waller




