



Housing Sector: Fastest Growing Sector in First Half of 2019


SHFA Issuance 2012 – 2019







2018 vs 2019


The First Half of the Year is Reflective of the Split of Multifamily and Single Family Issuance Since 2012

SHFA's Components of Debt




Components of Outstanding Debt for All SHFAs






SHFA's Equity Continues to Grow


